PRIVACY POLICY

The Town of Bowdoin, State of Maine, (hereinafter referred to as “Town”) takes your privacy seriously. Please read the following to learn more about our privacy policy.

What this Privacy Policy Covers

This Privacy Policy covers the Town’s treatment of personally identifiable information that the Town collects when you are on the Town web sites and when you use the Town’s on-line services.

Information Collection and Use

The Town may collect personally identifiable information when you subscribe for a Town on-line account, when you use certain Town services and products, or when you visit the Town web site.

When you subscribe with or contact the Town we may ask for your name, e-mail address, zip code, personal address, and phone numbers. Once you subscribe with or contact the Town, you are not anonymous to us. The Town also automatically receives and records information on our server logs from your browser including your IP address, Town cookie information and the page you requested. The Town uses information to fulfill your requests for certain products and services.

Information Sharing and Disclosure

The Town will not sell or rent your personally identifiable information to anyone. The Town will send personally identifiable information about you to other companies or people when:

- We have your consent to share the information;
- We need to share your information to provide the product(s) or service(s) you have requested;
- We need to send the information to companies who work on behalf of the Town to provide a product or service to you;
- We respond to subpoenas, court or legal process;
- We find that your actions on our web site violate the Town of Bowdoin Agreement for Internet Access, or any of our usage guidelines.

Your ability to Edit and Delete Your Account Information and Preferences

You may request deletion of your account by contacting the appropriate Town department.

Security

Your account information is transferred and stored securely. In certain areas the Town uses industry standard SSL encryption to protect data transmissions.

Changes to this Privacy Policy

The Town may amend this policy from time to time. If we make any substantial changes in the way we use your personal information we will notify you by posting a prominent announcement and sending out an email to all subscribers.
